In keeping with this Court's December 20, 2016 Order Granting Motion for Final Approval of Class Action Settlement Submitted by Matern Law Group, PC ("Final Approval Order") this Court hereby ADJUDGES and DECREES as follows:

1. Pursuant to the California Rules of Court, Rules 3.769(h), this Court now makes and enters this Final Judgment under which all Plaintiffs and Participating Class Members shall take nothing from Defendants, except as expressly set forth in the Final Approval Order.

2. Pursuant to the California Rules of Court, Rules 3.771(a), this Final Judgment, hence, binds the following Settlement Class:

All current and former non-exempt employees of DDI who worked in California, as well as all current and former non-exempt employees of staffing agency defendants, Staffing Network, Cornerstone Staffing Solutions, Inc., Dream Team Services, Inc., Aerotek, Inc., Manufacturing Pros, LLC, and Priority Business Services, who were employed by DDI in California or assigned to perform services at DDI in California at any time from August 25, 2010 through March 31, 2016.

except that the following five individuals, whom this Court has deemed "Opt-Outs" to the Settlement, shall not be bound by this Final Judgment: (1) Yeny Gallegos; (2) Carlos Gonzalez Reyes; (3) Lourdes Murillo; (4) Elenor C. Nunez; and (5) Edna Soledad Moreno.

3. Pursuant to California Code of Civil Procedure section 664.6 and California Rules of Court, Rule 3.769(h), this Court shall retain jurisdiction over the Parties and Participating Class Members with respect to enforcement of this Final Judgment including, but not limited to, all matters related to the interpretation, administration and consummation of the Settlement.

3. Pursuant to the California Rules of Court, Rule 3.771(b), Settlement Administrator's posting of an electronic copy of the Final Judgment on the Settlement Administrator's website shall be deemed due and sufficient notice of entry of this Final Judgment.
